ORDER

As per the Government Order read as first paper above sanction was accorded to M/s Kerala Small Industries Development Corporation Ltd., (SIDCO) to avail the concession under para 57(a)(ii) of Stores Purchase Manual for the year 1998-1999 for the supply of items manufactured by them except on items available under State Rate Contract and Director General of Supplies and Disposals Rate Contract as a special case. Thereafter, Government have extended the period of validity of the said concession/relaxation from year after year. The period of validity of the relaxation, extended as per the Government Order read as 3rd paper above will expire on 26-11-2011.

The Managing Director, M/s SIDCO in his letter read as 4th paper above has requested Government to extend the period of validity of relaxation of para 57(a)(ii) of Stores Purchase Manual for a further period of two more years from 27.11.11.

Government have examined the matter in detail and are pleased to extend the period of validity of relaxation of para 57(a)(ii) of Stores Purchase Manual for a further period of one more year from 27-11-2011, so as to enable SIDCO to supply Steel Furniture

manufactured by them directly to all Government Departments/ Public Sector Undertakings/ Local Bodies/ Autonomous Institutions etc., without tender. The price of the Steel Furniture should be in accordance with that fixed as per the Government Order read as 2nd paper above. (Copy of the price of Steel furniture is enclosed as Annexure to this Government Order for ready reference).

All Government Departments/ Public Sector Undertakings/ Local Bodies/ Autonomous Institutions etc., can purchase their requirement of Steel Furniture directly from SIDCO, at the rates not exceeding that fixed vide the Government order read as second paper above, for a period of one more year from 27.11.2011.
