**Abstract**

Stores Purchase Department - Purchase of Wooden Furniture from M/s Kerala Small Industries Development Corporation Ltd (SIDCO) by Government Departments/Public Sector Undertakings/ Local Bodies/ Autonomous Institutions etc., without following Tender formalities - Relaxation of Para 57(a)(ii) of Stores Purchase Manual - Extension of Period of validity - Orders issued.

**ORDER**

As per the Government Order read as first and third papers above, Government have permitted M/s Kerala Small Industries Development Corporation Limited (SIDCO) for supplying Wooden Furniture directly to all Government Departments/ Public Sector Undertakings/ Local Bodies/ Autonomous Institutions etc., without following tender formalities, in relaxation of para 57(a)(ii) of Stores Purchase Manual. Initially this relaxation had been granted for a period of one year and subsequently it has been extended year after year.

As the period of validity of relaxation extended, vide the Government Order read as 4th paper above will expire on 19/11/2011, the Managing Director, SIDCO in his letter read as 5th paper above has requested Government to extend the period of validity of the relaxation for a further period of two more years from 20.11.2011, so as to enable them to supply Wooden Furniture directly to all Government Departments/ Public Sector Undertaking/ Local Bodies/ Autonomous Institutions etc., without tender formalities.

Government have examined the matter in detail and are pleased to issue orders for extending the period of validity of relaxation of para 57(a)(ii) of Stores Purchase Manual for a period of one more year from 20-11-2011, so as to enable SIDCO to supply Wooden Furniture directly to all Government Departments/

Public Sector Undertakings/ Local Bodies/ Autonomous Institutions etc., without tender formalities. The price of the Wooden Furniture should be in accordance with the Government Order read as 2<sup>nd</sup> paper above, until it is revised. (Copy of the price list is kept as annexure to this Government Order for ready reference).

All Government Departments, Public Sector Undertakings, Local Bodies, Autonomous Institutions etc., can purchase their requirement of Wooden Furniture directly from SIDCO for a period of one more year from 20.11.2011 without exceeding the price fixed by the Government, as per the Government Order read as 2<sup>nd</sup> paper above, until it is revised.
