## **ORDER**

As per Government Order read above 'Dies non' was imposed to those employees who struck work during the general strike declared by a section of Government employees and teachers from 08.01.2013. In continuation to the above, Government are pleased to issue the following further orders.

- 1. Since the strike was declared withdrawn in the early hours of 14.01.2013 (viz 1.30 AM) 'dies non' will be enforced only upto and including 13.01.2013 (ie, those who were unauthorisedly absent on 11<sup>th</sup> January will not be eligible for salary for 12<sup>th</sup> & 13<sup>th</sup>).
- 2. Applications for leave received after the strike days will not be entertained.
- 3. Salary of the employees who struck work is to be recovered from the <u>salary for</u> the month of January 2013 itself. If by a rare chance, this is not possible, the amount will be recovered from the February 2013 salary.
- 4. Strict disciplinary action will be initiated against those who claim salary for the days they struck work. If anyone on strike claims salary, it will be treated as misappropriation of Government money.
