As per GO cited above, we have selected 31549 Accredited Social Health Activists (ASHA) and were deployed in the field by giving induction training in fourteen districts from 2007 onwards. Performance linked incentives payable to ASHA at different periods have been detailed in the references mentioned above. However, since the sources of funds from which these amounts are to be paid differ based on the change in programme head from which the incentive is to be paid, the following revised detailed guidelines are issued for payment of incentives to ASHA.
