In the Government Order read above, Government have revised the Pay and Allowances of State Government employees and Teachers. In partial modification to the Orders there in, the Government are pleased to modify the Pay and Allowances of certain category of posts in Health Services Department coming under Public Health and MCH wing as follows:-

1. The Scale of Pay of Junior Public Health Nurse Gr I and Junior Health Inspector Gr I shall be modified from ₹13210-22360 to ₹13900-24040.

2. 1/3rd of the total posts each of Lady Health Supervisor and Health Supervisor in the Scale of Pay of ₹16180-29180 shall be placed in Higher Grade in the scale of pay of ₹18740-33680.

3. The existing ratio of 2:1 between Gr II and Gr I posts of Junior Public Health Nurse and Junior Health Inspector shall be modified as 1:1.

Accordingly the following modifications shall be made in the department schedule of Health Services under the captions MCH WING and PUBLIC HEALTH wing appearing on page 149 of the GO read above.

4. The rate of Uniform Allowance of Junior Public Health Nurse mentioned under Annexure VIII below the caption Health Services appearing on page 71 of the GO read above shall stand modified from ₹1400 to ₹1600.

5. The Permanent Conveyance Allowance applicable to Junior Public Health Nurse Gr I shall be revised from ₹100 to ₹150. Accordingly the following designations under the caption Health Services of Annex XI appearing on page 88 of the GO read above shall stand modified as follows:-


